1. Introduction

Thank you for your interest in the European Master of Science in Occupational Therapy!

The OT-EuroMaster is a truly international programme which enables students to study in 5 different European countries (the UK, the Netherlands, Switzerland, Spain and Sweden) at the cooperating partner universities mentioned above.

It is the first of its kind. We operate in the 'spirit of a joint degree' across each institution. This means that staff work as a team in the development and delivery of a fully integrated curriculum.

In 2016 and 2023, the programme received the European Consortium for Accreditation's Certificate for Quality in Internationalisation.

The European Master of Science in Occupational Therapy is a government-subsidized study programme. It is accredited by NVAO¹ and approved and funded by the Dutch and the Swiss Ministries of Education and Sciences. The Amsterdam University of Applied Sciences (AUAS) and the Zurich University of Applied Sciences (ZHAW) are the degree awarding powers.

All OT-EuroMaster students are enrolled at Amsterdam University of Applied Sciences. Swiss citizen or resident and non-European Economic Area (EEA) citizen students will be enrolled both at Amsterdam University of Applied Sciences, and additionally at Zurich University of Applied Sciences Winterthur Switzerland. In addition to the NVAO accredited European Master of Science Degree that they receive from the AUAS, they receive the degree Europäischer Master of Science ZFH in Ergotherapie from ZHAW.

EU / EEA citizen students will be enrolled solely at Amsterdam University of Applied Sciences.

Every student will receive the same programme, will have to pass the same assignments, and will meet the same learning outcomes.

We all look forward to supporting you and contributing to deepening your understanding of occupational therapy and occupational science and building your research skills and your international network!

Start the application process early!

We advise you to start the application process early. Administrative Office will support you throughout this process. Please contact ot-euromaster@hva.nl if you need any assistance or advice. It is also possible to arrange an online or telephone conversation with a member of staff or to have contact with one of the current or former students, possibly from your country.

2. Admission criteria OT-EuroMaster

- Bachelor of Science in Occupational Therapy or equivalent
- International English Language Testing System (academic IELTS) score 6.5 or equivalent.

2.1 Bachelor of Science in OT or equivalent

Applicants should hold a Bachelor *of Science* degree in Occupational Therapy.

Other qualifications, plus a portfolio, which may be accepted as equivalent

Those who hold a *degree or diploma in Occupational Therapy* which is not a Bachelor of Science degree will be asked to submit additional documents, such as for example your final Bachelor thesis or a detailed overview on the content of your OT-education programme. Admission Committee will let you know which documents they will need.

If you are not an Occupational Therapists, but you have a ***Bachelor of Science in a field related to OT*** you might be able to gain admission after submitting an extensive portfolio and letter of motivation, evidencing that you have sufficient knowledge and understanding of Occupational Therapy and/or Occupational Science and that you have achieved the requested entrance competences listed in annex 1 on p. 8. Please contact ot-euromaster@hva.nl to check whether your field is related.

Please be aware that this programme does not lead to a professional qualification and license to practice as an Occupational Therapist.

Admission committee will look into each portfolio individually and consider whether the person concerned has attained the requested entrance competences by previous work and/or study.

No admission is possible for those holding a degree which is not a Bachelor of Science degree in a field related to OT.

2.2 English language test

Applicants are required to prove that they have very good command of the English language by submitting evidence of an overall band score of at least 6.5 for the **ACADEMIC** IELTS²-test, or of a comparable score. Please note that the *online IELTS-test is not accepted*.

The following test scores are accepted as equivalent to an Academic **IELTS** score of 6.5:

- a. **TOEFL**³ Paper: 575
- b. **TOEFL** Computer: 232
- c. **TOEFL** Internet: 90
- d. **TOEIC**⁴ Listening and Reading: 720 in combination with TOEIC Speaking and Writing: 310
- e. **Cambridge** Advanced⁵ CAE: Grade C (scale 180-192)

These are the only alternative test scores we can accept with your application.

Please make sure that you plan for the English test early – you need to register in time for the testdate because it takes some weeks after you have done the test until you get the official result which you need to hand in with your admission documents.

3. Application

Have you decided to apply for the OT-EuroMaster? Please check all steps of the application process and the admission criteria in good time. The administrative office is ready to support you in this procedure.

Application is open from October 1st until end of April.

You must finalise step 1 (registering on Studielink) and step 2 (uploading the application documents) before 1 May.


3.1 Step one: Register on Studielink

For registration on Studielink: studielink.nl

If you live in the Netherlands, you can log in on the Studielink website using your DigiD. If you do not have a DigiD, you can request one via the [DigiD-site](#) (it can take up to 3 working days until you receive the DigiD).

If you do not live in the Netherlands, you must apply for a username and password by clicking on the 'Create account' button.

Within Studielink, choose the OT-EuroMaster as follows:

Activate your AUAS ID and e-mail

After registering on Studielink, you will receive several automated e-mails, one of which includes the invitation to activate your AUAS ID and your AUAS email:

- As a future AUAS student, you will be given your own AUAS ID and email account.
- Your AUAS ID provides access to the digital resources offered by the AUAS.
- Be sure to regularly check this inbox to ensure you don't miss any important information.
- To log in to your email account, you will first need to activate your AUAS ID on id.student.hva.nl using the details that will be emailed to you after the AUAS has processed your enrolment request.

3.2 Step two: Upload application documents

After having registered on Studielink, you will receive a second link with the invitation to upload your application documents onto the "Serviceportal".

A) If you have a **Bachelor of Science degree in Occupational Therapy**, you will have to upload the following documents:

- **Scan of your original BSc diploma and international diploma supplement.** Both with a **certified English translation**. Diplomas in English, Dutch, French, German, Italian, Spanish or Afrikaans, do not need to be translated.
- An English certificate with test score of the **academic IELTS** (or equivalent test, see 2.2)
- **Curriculum Vitae** in English; addressing education, work experience, and further professional and academic training courses
- 2-page **motivation letter** in English concerning your level of competence and motivation for applying to the European Master of Science in Occupational Therapy programme
- Copy of your **passport**

B) If you have a **diploma or another degree (not a BSc) in Occupational Therapy or a Bachelor of Science in a related field**, you will have to upload the following documents:

- **Scan of your original Diploma and International diploma supplement.** Both with a **certified English translation**. Diplomas in English, Dutch, French, German, Italian, Spanish or Afrikaans, do not need to be translated.
- An English certificate with test score of the **academic IELTS** (or equivalent test, see 2.2).



- **Curriculum Vitae** in English; addressing education, work experience, and further professional and academic training courses.
- 2-page **motivation letter** in English concerning your level of competence and motives for applying to the European Master of Science in Occupational Therapy programme.
- Copy of your **passport**.
- Professional **portfolio**⁶ (see annex 1 and 2 for further information).

3.3 Tuition fees

The fee for EU/EEA citizens is 2,695 Euro for the academic year 2026-2027.⁷ A slightly different fee applies for non- EU/EEA citizens. Please contact ot-euromaster@hva.nl for further information. For Swiss residents Swiss semester fees apply.

Depending on your citizenship and/or residency, you will be additionally enrolled at ZHAW - this is to make sure everyone pays a comparable tuition fee.

The tuition fee does not include additional costs, such as travel and accommodation expenses and the costs of studymaterial.

4. Visa

You will study in 5 different countries. It will be 2 weeks stay in modules 1 to 4 each and a 1 week stay in module 5. Depending on your citizenship, country of residence and your specific situation it may be necessary to apply for a short stay visa. Since the OT-EuroMaster is a part time programme it's not possible to apply for a long stay visa.

The first country to travel to is the **United Kingdom** in September. **For travelling to the UK, everyone needs a valid passport** (personal ID is not accepted) **and an Electronic Travel Authorisation ETA**. Instructions to receive the ETA will be sent in due time before the start.

We strongly advise you to start preparing your visa application documents as early as possible and submit them 3 months in advance.

Do make sure that all the papers are correct and complete. If not, your visa application may be rejected.

Once your admission to the programme has been confirmed, you will receive an admission statement and an admission letter. For module 1, all students will receive an invitation letter from University of Brighton. On your request, you will also receive an invitation letter from each institution concerned, for the visa application in the specific country prior to each module. However, gathering all other documents and the visa application itself needs to be done by you.

5. To use only *recent* documents.

Annex 2: Portfolio

What is a portfolio?

A portfolio is an instrument to show the personal and professional skills you have to offer. With a portfolio, you can show that you meet the requested entrance competences. The portfolio contains one or several products that demonstrate the knowledge and skills you have acquired through your education, experience in occupational therapy practice and lifelong learning.

Please add a description explaining how each product links to the different fields of the entrance competences and how it shows that you have reached the required level of the competence (shown in annex 1) and are able to study at Master of Science level.

The admission committee examines the portfolio to assess whether you have acquired a sufficient level in all five fields of the entrance competences (see annex 1).

Applicants with a Swiss (non-BSc-) diploma and a „Nachträglicher Titelerwerb“ need to hand in their diploma and the NTE-Certificate as a portfolio.

Examples of suitable evidence

- A report, presentation, writing, article or other product that presents the process and outcomes of a clinical project that you led or took part in.
Please note: if you refer to a published article, please provide a pdf-version or a link to an online copy of the article.
- A certificate of a post-graduate course with an English summary of the content of the course and a description of the competences you gained through completing this course.
- A critically appraised paper (CAP) or topic (CAT). Look for more information [here](#) and find a template for a CAT [here](#).
- An extended case study of a clinical situation and an essay on theoretical and/or practical Occupational Therapy (OT) or Occupational Science (OS) aspects using relevant OT and/or OS literature.
- A bachelor final thesis supplemented by a follow-up research outline using relevant methodological literature.
- A literature review of a topic within Occupational Therapy/Occupational Science
- A report of a research project that you took part in (describing clearly your role, e.g. assisting in data collection).

How many products are needed?

Your portfolio and your degree should cover all five entrance competences. Some competences may be clear from your education; if so, only the missing competences should be demonstrated in your portfolio. One product can give evidence of more than one competence. Usually, more than one product is needed.

Does the portfolio have to be in a paper form?

No, the portfolio can be made in a form that suits you. Be creative! The use of a website or presentation programme like PowerPoint or Prezi is also possible. Remember to organise and structure your portfolio so it shows you possess the entrance competences.

Example of part of a portfolio

Portfolio Anna Hoogenkamp

This portfolio shows my personal and professional skills acquired until now through my education, experience in practice and lifelong learning. The pieces of evidence are supplemented with a description on how each product links to different fields of the entrance competences. Etc....
